Community update



Power station decommissioning

As part of Alcoa of Australia's decommissioning of the Anglesea power station and mine, the main power station building was scheduled to be felled using controlled explosives on 30 May. The demolition activity, which was safely executed, did not result in the complete collapse of the structure.

Alcoa is continuing to work with the principal contractor to assess the remaining structure and plan for its demolition. Analysis on why the structure only partially collapsed continues to be undertaken. The outcome of this analysis will inform the method for the demolition of the remaining structure.

Given this ongoing work, it is currently expected that further demolition activity will occur towards the end of July.

Work is also ongoing to ensure the continued safety of onsite personnel and the community.

Monitoring instrumentation continues to confirm the structure is stable; there has been no movement in the structure.

Air monitoring remains in place and has not detected any airborne asbestos fibres. As stated previously, the demolition occurred following a twelve-month asbestos removal program. A safety exclusion zone remains in place and continues to be monitored by security officers 24 hours per day. Worksafe and EPA Victoria continue to be closely informed about activities at the site and both agencies have issued public statements about the demolition activity.

Alcoa is committed to keeping the community informed of its activities through advertising and regular Alcoa Community Consultation Network (CCN) meetings.

Held bi-monthly, Alcoa CCN meetings provide the opportunity for two-way communication regarding issues that are important to the Anglesea community and Alcoa.

Lease extended for Anglesea Bike Park

Alcoa is proud of its long history of support for the Anglesea Bike Park.

In 2006 Alcoa supported the establishment of the bike park on one hectare of Alcoa freehold land following the closure of the local BMX track. This included funding the design and construction of the mountain cross 4-X track.

Since then Alcoa has leased the land to the Surf Coast Shire, at no cost, to host the bike park.

Alcoa believes it makes sense that a community facility like the bike park be located on public property to provide increased long-term security for the community, and to provide the opportunity for future improvement and expansion.

In line with Alcoa's public commitment to support a smooth transition for the Anglesea Bike Park, Alcoa has extended the lease for the park for six months until 31 December 2018.

The extension will allow time for all parties to ensure that all long-term options for the bike park, inclusive of reviewing the Anglesea Futures Land Use Plan when released by the Victorian Government, have been identified and can be fully considered.
